

## Facility and Residential Services

(Apply Directly to Each Facility)

### Welfare Facility for the Elderly

(Special Nursing Home for the Elderly)

Care staff provides support during meals and bathing, and also carries out functional training for bedridden patients or dementia sufferers who have trouble with receiving care at home.

After determining the applicant's care need level and family situation, those who are found to be in urgent need of care are given priority to enter the facility. From April 1, 2015, new residents must be Care Level 3 or higher. (Those who are certified as Care Level 1 and 2, and are applicable to exceptional requirements of the facilities are eligible to enter the facility. See below for user costs.)



Community-Based Service (Special Nursing Home for the Elderly)

### Community-Based Welfare Facility for the Elderly

Care staff provide assistance with meals, bathing, and functional training to residents of small-sized special nursing homes with a capacity of 29 or fewer.

From April 1, 2015, new residents must be Care Level 3 or higher. (Those who are certified as Care Level 1 and 2, and are applicable to exceptional requirements of the facilities are eligible to enter the facilities. Refer to the information below regarding user costs.)

### Health Service Facility for the Elderly

This facility supports the elderly and dementia sufferers requiring nursing or care to help them return to living at home. An integrated set of services covering medical care, including rehabilitation and other assistance in everyday living are provided.

(Those certified as Support Level 1 and 2 cannot use this service. See below for user costs.)

### Sanatorium-Type Medical Care Facility

(Hospitals, etc. with a full staff that provides thorough care)

Those who need long-term treatment can receive care, functional training, and other medical care needs under medical supervision. (Those certified as Support Level 1 and 2 cannot use this service. See below for user costs.)

Community-Based Service (Special Nursing Home for the Elderly)

### Facility Service Costs and User Costs

Facility service costs vary depending on care level, type of facility, and the number of staff.

Users bear 10% or 20% of expenses, and the full cost of meals and accommodation.

Note:

-Monthly cost for 31 days

-There is an upper limit for costs borne by the user set based on income.

-For low-income users, the upper limit for meal and accommodation costs is set according to income.

-User bears other daily living costs, etc.
