To be Held as Part of 3rd World Water Forum March 18-19, 2003, OSAKA

"The Future Direction and International Role of Aquapolises"

The newsletter Aquapolis No.4 reported that the 4th International Conference of Aquapolises (ICAP) would be held in the City of Vienna. However, for certain reasons, the city asked the ICAP Osaka Secretariat to allow the city to decline to host the Conference. After consultation with directorial cities of ICAP, Vienna's request was approved.



Following the approval, the ICAP Osaka Secretariat proposed that, for the reasons listed below, the 4th ICAP be held as an additional section meeting of the 3rd World Water Forum, which is scheduled to take place on March 16 to 23, 2003, in Kyoto, Osaka and Shiga prefectures. The proposal was put to the vote among directorial cities, and was then bolstered by a majority.

the world," coincides with the purpose of ICAP. In addition, the theme of the "Osaka Day" program, an event of the Forum, is "Water and City." If the 4th ICAP is held as part of the Forum, many of the Forum's participants from around the world will take part in the Conference as well, giving the Conference added importance.

Therefore, the ICAP Osaka Secretariat will be able to manage both these meetings and the 4th ICAP without the need to establish a separate secretariat. The ICAP theme session "Water and Cities" will be chaired by a coordinator from the United Nations Human Settlement Programme (UN-HABITAT).

1st ICAP, Osaka, July 1990
Theme: Water and Greenery

Osaka Declaration

We renew our recognition that the continued development of cities relies on the harmonious coexistence of nature and people. With the diversification and expansion of human activities, however, it has become increasingly difficult to strike a balance between urban development and environmental conservation. Each participant city is dedicated to playing a leading role in forming a worldwide consensus for the conservation and improvement of the global environment, fully recognizing that urban activities, individually and collectively, will exert a great influence on global-state environmental improvement.

2nd ICAP, Shanghai, November 1993
Theme: Water and Regional Development

Shanghai Declaration

- 1) The protection and supply of water - the greatest resource of aquapolises and new technologies in sewage-treatment.
- 2) New ideas, new concepts and new measures in urban planning and harbor construction of the 21st Century Aquapolises.
- 3) The crucial linking between urban economic growth and environmental protection for the purpose of improving urban environmental efficiencies.
- 4) The expansion and development of urban greenbelts, greenery of city, beautification of surroundings, so as to achieve better ecological effects and improve ecological conditions.
- 5) Prevention of natural calamities and introduction of technical control measures.

3rd ICAP, Piraeus, March 1997
Theme: Water and Tourism

Piraeus Declaration

1. There must be a harmonious relationship among nature, society, and economic development. This must be taken into consideration in urban planning.
 2. In the framework of well-balanced development, natural resources must be conserved to a sufficient extent.
 3. Systematic engineering works and infrastructure development must contribute to environmental protection and control exploitation of natural sources, in such a way as to achieve sustainability in the 21st century.
- The significance of international conferences focused on the above subjects was emphasized.
